

**SAFARI CLUB INTERNATIONAL
2020 MEMBERSHIP CAMPAIGN SWEEPSTAKES PROMOTION**

OFFICIAL RULES

NO PURCHASE OR CONTRIBUTION NECESSARY. A PURCHASE OR CONTRIBUTION WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: The Safari Club International 2020 Membership Campaign Sweepstakes Promotion ("Promotion") is open only to legal residents of the 50 United States (excluding Washington), the District of Columbia, or Canada (excluding Quebec) who are at least 18 years of age (or the age of majority in their state or province of residence, if greater than 18) or older at time of entry. Void in the state of Washington, Quebec, Canada and where prohibited. Persons in the following categories are not eligible to participate or win a prize: (a) employees of Safari Club International ("Sponsor"), and its parent, affiliates, subsidiaries, advertising and promotion agencies; (collectively the "Sweepstakes Entities"); (b) individuals or entities responsible for the development, printing, distribution and implementation of this Promotion; and (c) persons who are employees of or members of the immediate family (parents, siblings, children & spouse) or household of any person in any of the preceding categories. By participating you agree to be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

2. PROMOTION PERIOD: Promotion starts on or about 12:00:01 a.m. Mountain Time (MT) on January 1, 2020 and ends at 11:59:59 p.m. MT on December 31, 2020 ("Promotion Period"). This Promotion consists of twelve (12) individual Monthly Drawings, and one (1) Grand Prize Drawing. Each Monthly Drawing begins at 12:00:01 a.m. MT on the first day of each calendar month during the Promotion Period, and ends at 11:59:59 p.m. MT on the last day of each calendar month during the Promotion Period.

3. HOW TO ENTER AND PARTICIPATE: There are two ways to enter each Sweepstakes. **(a) Membership Method:** During the Promotion Period, join SCI or renew or upgrade your SCI Membership by (a) following all instructions to complete and return an official "Join or Renew and Upgrade to 3 Year, Life or LHAS SCI Membership" Response Form; (b) calling 888-486-8734 to speak to an SCI representative using promotional code 12MSS; or (c) log onto www.scifirstforhunters.org/sweepstakes ("Website") and follow the online instructions. Entrants participating via the Membership Method will receive the following number of entries (up to a maximum of five (5) entries per person, per drawing) into the Grand Prize Drawing and into each Monthly Drawing held after their payment has been received for the corresponding Membership selection:

(b) Alternate Method of Entry: To enter the Promotion without joining SCI or upgrading your SCI membership, complete a 3" x 5" card with your name, address, age, and daytime phone number legibly hand-printed in ink in capital letters, then sign your name in ink at the bottom of the card. Mail the card with sufficient pre-paid postage to Safari Club International Sweepstakes Entry, 4800 W. Gates Pass Road, Tucson, AZ 85745-9490. Limit one (1) Monthly Drawing entry and one (1) Grand Prize Drawing entry per outer mailing envelope. All mailed entries must be postmarked by the last day of the calendar month of the applicable Monthly Drawing, and received by SCI by seven (7) days thereafter. If the last day of the calendar month falls on a Sunday or legal holiday, the mailed entry must be postmarked by the following day, and received by SCI by seven (7) days thereafter. You will receive one (1) entry into the Grand Prize Drawing and one (1) entry into each Monthly Drawing occurring after your mail-in entry is received.

4. SELECTION OF WINNERS/ODDS OF WINNING:

One (1) prize winner will be selected in a random drawing for each Monthly Drawing by Sponsor approximately fifteen (15) days after the end of each 2020 calendar month from among all eligible entries received for that Monthly Drawing. One (1) Grand Prize winner will be selected in a random drawing approximately fifteen (15) days after the end of the Promotion Period from among all eligible entries received during the Promotion Period. Each potential winner is subject to verification and compliance with these Official Rules. Odds of winning a Monthly Prize depend on the number of eligible entries received for that Monthly Drawing. The odds of winning the Grand Prize depend on the number of eligible entries received during the entire Promotion Period. If a Canadian resident is selected, prior to being confirmed as a winner of a prize, the potential winner must correctly answer a mathematical skill-testing question.
